4. How can I attest to the 2020 Model of Care training on behalf of a specialty group or clinic with multiple providers?

Email the attestation and an eligible scanned copy or photo of the completed sign-in sheet to Provider education@blueshieldca.com. The group attestation form and a PDF of the course can be found available on our website at blueshieldca.com/promise.

This form should be signed by a medical director, clinic administrator, or physician with signature authority on behalf of the specialty group or clinic.

- 5. Will Blue Shield Promise honor completion of SNP Model of Care training provided by another health plan or IPA?
 - Yes, you will receive credit for completion if you send the signed attestation from the training to Provider_education@blueshieldca.com.
- 6. How can I obtain proof of completion for the Blue Shield Promise 2020 Model of Care training if none was provided?
 - You will not receive physical confirmation of completion. Blue Shield Promise creates a record of completion when providers sign the attestation at the end of the course (or when a groups submits the 2020 Cal MediConnect and Dual-Eligible Special Needs Plan Model of Care Training Group Attestation and Sign-in Sheet). If you feel you have been erroneously identified as non-compliant, please contact your IPA.
